1. RATIONALE

Education at OneSchool Global Vic depends on the provision of a school environment that is safe and without risk to the health and wellbeing of staff and students. Safety and Wellbeing in the school environment embraces the responsible care of all personnel, physically, socially and emotionally.

This embraces, but is not exclusive to, the areas of:

- Student Wellbeing
- Staff Wellbeing
- · Workplace Health and Safety
- Site and Facility Emergency Management
- Mandatory Reporting and Child Protection (Ministerial Order 870)
- Child Safe Standards (The 11 Standards July 2022)

2. AIMS

Safety and Wellbeing is to be regarded as a prime consideration in planning, development, implementation, and operation of all aspects of the school environment.

A school environment must be provided where students, teachers, parents and visitors can attend without risk.

Clear and concise documentation is provided that can be accessed, understood and administered by any responsible adult.

All personnel involved with the School carry a joint responsibility to maintain Safety and Wellbeing.

3. IMPLEMENTATION

The Safety and Wellbeing Policy is the responsibility of the Campus CA and The Head of Campus as the nominated Safety and Wellbeing Officer.

All Safety and Wellbeing documentation is to be kept current and accessible at each campus location.

The relevant Standards and Regulation documents are to be held by the School and any School procedures are to reflect such documents to ensure legal compliance.

All OneSchool Global Vic campuses operate within the guidelines of *Ministerial Order 870* (Consolidated_MO870_with_1324_amendments.pdf (education.vic.gov.au)) in relation to child safety policies.

In addition, all OneScool Global Vic campuses operate within the guidelines of the Child Safe Standards – The 11 Stamdards – July 2022 Child Safe Standards Information Sheet 30.01.23 (ccyp.vic.gov.au)

All procedures must consider Access and Equity and ensure that Disability and Discrimination issues are addressed, as per the Disability Discrimination Act

(Federal Register of Legislation - Disability Discrimination Act 1992)

 - 3.1.5 OneSchool Global Vic has a xero tolerance policy in relation to matters associated with child safety in line with Ministerial Order 870 Child safe standards and The 11 Standards.

- acquainted and responsible to ensure a safe, risk free environment where learning can take place.
- encourage co-operation and communication between management and staff to ensure the aims are fulfilled.
